# Introduction

This report catalogues all that is concluded, "conclusions," in official G8 documents related to the issue area of the Balkans. It refers to all official statements and annexes released by the leaders as a group at each annual G20 summits from 2008 to 2010.

The Balkans were under Soviet rule until after the Cold War (late 1980s-early 1990s) when Westernization spread with political, social, economic and market reforms. The G8 has been concerned with Balkan safety and security in light of past and on-going regional ethnic and religious tensions, democratic reform efforts, and an ever-increasing demand for freedom and the rule of law. The G20 has not yet made any direct references to the Balkans save to thank Turkey for hosting the Fourth UN LDC Summit in 2011.

## **Definition of Issue Area**

The Balkans is a region of southeastern Europe. It includes the countries of Albania, Bosnia and Herzegovina, Bulgaria, Croatia, Greece, Kosovo, Macedonia, Montenegro, Serbia, Slovenia, Romania and Turkey.

<sup>&</sup>quot;# of Dedicated Documents" is the number of documents for the year that contain a Balkans-related subject in the title.
