Background

Key announcements included genomic data sharing between countries (essential for better monitoring of pathogens of concern); commitments on allowing the continued movement of people, goods and services during health emergencies; and a commitment to conduct a gap analysis and mapping exercise of existing and emerging vaccine research and manufacturing networks.

On the critical issue of financing, G20 members detailed the Pandemic Fund, which is designed to finance critical investments that can strengthen pandemic prevention, preparedness, and response capacities, specifically in low- and middle-income countries. The fund aims to provide a long-term financing stream focused on strengthening health systems.

According to the World Health Organization (WHO), the Covid-19 pandemic has marred global progress towards universal health coverage (UHC), constituent to the Sustainable Development Goals, which aim to ensure that "all people have access to the full range of quality health services they need, when and where they need them, without financial hardship."1622 Access to COVID-19 Tools (ACT) Accelerator, a global effort to "accelerate development, production, and equitable access to Covid-19 tests, treatments, and vaccines," is fundamental to ensuring equitable access to pandemic protections. 1623 G20 members reiterated their commitments to "strengthen global health governance" in the aftermath of WHO's declaration of monkeypox as another Public Health Emergency International Concern. 1624 In order to "strengthen global

health governance," G20 members reaffirmed their commitment to collaborating with WHO and "other international organizations."

At the 2014 Brisbane Summit, G20 leaders expressed their concerns over the Ebola virus outbreak in Guinea, Liberia, and Sierra Leone. In their joint statement on the Ebola virus, the G20 committed to perform the required actions to channel international effort towards the mitigation of outbreak and address its medium-term economic and humanitarian costs. In addition, the G20 recommitted to implementing the WHO International Health Regulations (IHR) (2005) to better "prevent, detect, report early and rapidly respond" to infectious diseases.

At the 2017 Berlin Summit, G20 Health Ministers published the joint Berlin Declaration, where they acknowledged the importance of international cooperation to address global health-related challenges. The Declaration supported the leading role of the WHO in expanding methods for raising capacity and preparing for improved responses to health emergencies while emphasizing the G20's need to contribute to joint commitment and action in close cooperation with WHO.

At the 2018 Buenos Aires Summit, G20 members stated that efforts to counter antimicrobial resistance (AMR) was becoming a "global responsibility," requiring more multi-sectoral action. G20 members also stated their commitment to move towards UHC, through stronger health systems to achieve better access to higher-quality healthcare. Lastly, G20 members emphasized their commitment to improve core capacities required by the IHR (2005) to better prevent, detect and respond to future public health emergencies."

At the 2019 Osaka Summit, the G20 members restated their commitment to achieving UHC, asserting that public health care "is a cornerstone for advancing health and inclusion." The G20 members expressed their support for strengthening health systems, focusing primarily on the health workforce and human resources for policy development. Additional support was also asserted towards promoting public and private sector innovation. In their continued collaboration with WHO, the G20 members reaffirmed their compliance with the IHR (2005) and agreed to improve public health preparedness and response by strengthening the core capacities of members and the supporting capacities of other countries.

At the 2020 Riyadh Summit, G20 leaders prioritized the response to the Covid-19 pandemic and committed to taking all necessary health measures and ensuring adequate financing to contain the pandemic and protect people, with emphasis on the most vulnerable. The G20 members supported WHO's leading role in pandemic preparedness, response and further committed to "provide immediate resources" to WHO to facilitate global efforts to tackle the Covid-19 pandemic. In addition, the G20 members committed to increasing pandemic preparedness spending, achieved through increasing research and development funding for vaccines and medicines to strengthen national, regional, and global capacities to respond to potential disease outbreaks in the future. Finally, the G20 members restated their commitment to full implementation of the IHR (2005).

At the 2021 Global Health Summit in Rome, G20 members reaffirmed that the COVID-19 pandemic is a global health and socio-economic crisis, with disproportionate effects on the most vulnerable, on women, girls and children, frontline workers and the elderly. 1630 G20 members acknowledged the need to increase efforts to ensure timely, global and equitable access to safe, effective and affordable COVID-19 tools. 1631

In addition, the G20 members emphasized the importance of COVID-19 Vaccines Global Access (COVAX) as the pillar of the Access to COVID-19 Tools (ACT) Accelerator¹⁶³² to advance the sharing of safe, effective, quality and affordable vaccine doses globally.¹⁶³³

At the 2021 Rome Summit, G20 leaders stated their commitment to "ensure timely, equitable and universal access to safe, affordable, quality and effective vaccines, therapeutics and diagnostics," paying particular attention to low- and middle-income countries. 1634 The G20 also expressed support for all pillars of the ACT Accelerator, including COVAX, to reduce vaccination gaps. Moreover, the G20 members recalled their commitments to achieve UHC and fully implement the IHR (2005). Lastly, the G20 reaffirmed the repercussions of the pandemic on mental health and well-being, pledging support to the strengthening of national health systems and primary health care services.

Commitment Features

At the 2022 Bali Summit, G20 members "reaffirmed [their] commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations." This commitment can be broken down into two components, and to achieve full compliance, G20 members must take action in both components. The components are: 1) strengthening global health governance through emphasizing the leading and coordination role of the World Health Organization, and 2) strengthening global health governance through support from international organizations other than WHO.

Secondary avenues associated with achieving fair standards for global health governance include ensuring fair wages, securing employment and working conditions free of harassment, violence, and labour rights violations.

"Reaffirm" is defined as affirming something again which was asserted strongly in the past. 1635

A "commitment" is defined as an agreement or pledge to perform an action in the future. 1636

"Strengthen" means to make something stronger. 1637

"Global health governance" refers to the use of institutions and guidelines to deal with health challenges and crises that require international cooperation to solve. 1638

"Leading" refers to taking on a prominent role to guide the functioning of a group. 1639

"Coordination" is the work and activity of a number of persons who individually contribute toward the efficiency of the whole. 1640

"Role" is the function assumed or part played by a person or thing in a particular situation. 1641

"WHO" refers to the World Health Organization, which is a specialized agency of the United Nations responsible for international public health, mitigating global health disasters and providing relief towards affected nations. 1642

"Support" refers to the action of providing aid, assistance, or backing up an entity. 1643

Lastly, the term "international organizations" refers to equivalent bodies of governance similar to the World Health Organization, United Nations, World Bank, Red Cross and International Monetary Fund that are entities established by formal political agreements between their members that have the status of international treaties; their existence is recognised by law in their member countries. 1644

This commitment has a breadth component regarding how many international organizations G20 members engage with. As the commitment refers to WHO as well as "other international organizations," it is implied that members committed to creating a system of global health governance with more than one institution beyond WHO. However, as the commitment explicitly identifies WHO, the G20 member needs to take strong action to strengthen the role of WHO to achieve a score of +1.

Due to the fact that the commitment is a reaffirmation of a past commitment, the G20 member must take new actions in the area of global health governance. "Reaffirm" is a low binding commitment word, meaning that full compliance does not require strong action, but rather actions that are substantive enough to demonstrate the G20 member's commitment to strengthening the global health governance system.

Actions, initiatives and commitments pertaining to the fulfillment of the compliance goals include: 1) launching programs across public and private sectors to collect, analyze and utilize public health data, 2) mitigating the impacts of health issues, whether estimated or unexpected, through governance through collaborative efforts with international organizations, 3) establishing new channels, improving existing channels for the delivery and supply of healthcare materials, including drugs, chemicals, machines and acumen to the general public, 4) ensuring good governance to help patients receive safe, good-quality care encompassed under proper financial management, 5) realizing the unique roles, responsibilities, and perspectives of clinical and operational staff that compose national healthcare systems, 6). provision of services, health workforce, health information systems, access to essential medicines, financing, and leadership, 7) streamlining the production of global public goods with the shared management of externalities across countries, the mobilization of global solidarity, and stewardship, 8) shifting patient decision making with their healthcare providers from passive care recipients to active agents with power and control, 9) continued evaluation of the role of laws and regulations and policies in maintaining and improving the health of the community, and 10) working with international organizations to prevent the incidence rate of diseases, communicable or deficiency induced.

The strength of compliance can be determined based on the types of domestic and international initiatives developed by G20 members, across public and private sectors. Instances of domestic actions include, but are not limited to: directing regulations, laws or statutes to accomplish healthcare goals, or initiating domestic programs that publicize content produced by WHO. Examples of weak domestic actions include but are not limited to: 1) discontinuing protocols or steps associated with the maintenance of healthcare systems, 2) incohesive strategies to transfer healthcare resources collaborated with international organizations to the general public, 3) poor execution of regulatory frameworks for the collection and analysis of healthcare data, 4) failure to mitigate issues outlined in national healthcare commitments, linked to disease control, resource dissemination, palliative care, infrastructure needs, 5) failure to instill regulatory checks or implementing guidelines that improve the health of the general public, 6) remaining passive when dealing with large scale national health crises, 7) failure to comply with established standards for healthcare in clinics, hospitals, hospices and other avenues of remedial support. Examples of weak international action include: 1) ignoring primary healthcare guidelines outlined by the WHO, 2) failure or prolonged obstructions in the supply, transfer of healthcare resources, 3) failure or prolonged complications in the implementation of committed healthcare protocols that are a part of international regulatory guidelines.

Full compliance, or a score of +1, will be given to G20 members that take actions to strengthen global health governance by emphasizing the role of WHO, AND that also engage with at least one other international organization in order to support WHO's role.

Partial compliance, or a score of 0, will be assigned to G20 members that take action to strengthen global health governance by emphasizing the role of WHO OR that only engage with other international organizations excluding WHO.

Non-compliance, or a score of -1, will be assigned if the G20 member fails to take any action towards the commitment OR takes action that is antithetical to the commitment.

Scoring Guidelines

-1	The G20 member has not taken any actions to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations OR has taken actions that are antithetical to the commitment.
0	The G20 member has taken actions to strengthen global health governance by engaging with the World Health Organization OR has engaged with other international organizations excluding WHO.
+1	The G20 member has taken actions to strengthen global health governance by emphasizing the leading and coordination role of WHO AND engaging support from other international organizations.

Argentina: +1

Argentina has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 30 November 2022, Pan American Health Organization (PAHO) Argentina held a 2,000-person race to raise global awareness against antimicrobial resistance. Argentina recognizes this is a growing global health issue and is a leading country in advocating for prevention against antimicrobial resistance.

On 14 February 2023, Minister of Health Carla Vizzotti participated in a panel for Vaccine Production in Developing Countries, during which global leaders in technology analyzed strategies for achieving sustainable development goals for vaccine production in the Americas. ¹⁶⁴⁶ She highlighted the collaboration between Argentina and Brazil for the manufacturing of mRNA vaccines and equitable access for other health technologies.

On 15 February 2023, PAHO and WHO met with Argentinian health authorities and the biopharmaceutical company Sinergium Biotech to support the manufacturing of mRNA vaccines. 1647 The goal was to evaluate the progress of the transfer of technological resources used to develop vaccines against the SARS-CoV-2 virus and other pathogens within the region.

On 21 February 2023, Argentina adopted new strengthened sanitary measures around their exports to protect and limit against the spread of avian influenza found in wild birds, including chickens in the

country. 1648 This virus created import bans and inflated egg prices to record highs. Thus, the Argentinian government committed ARS1 billion to support negatively affected producers.

On 6 March 2023, the National Ministry of Health and the National Administration of Laboratories and Institutes of Health delivered 135 vials of Purified Protein Derivative that detect tuberculosis to Paraguay. 1649 The vials were sent as humanitarian aid at the request of the Paraguayan Ministry of Health.

On 10 March 2023, Minister Vizzotti met with representatives of various scientific societies to discuss the regulation and implementation of Law 27, 680: Prevention and Control against Antimicrobial Resistance. 1650 This law aims to model advanced levels of regulation to stress urgency about antimicrobial resistance.

Argentina has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. It has taken substantive actions to increase global cooperation on pressing health concerns, such as antimicrobial resistance. It has also collaborated with international organizations such as PAHO and WHO in order to promote international health governance. These actions demonstrate Argentina's commitment towards upholding its previous pledge towards promoting global health governance.

Thus, Argentina receives a score of +1.

Australia: 0

Australia has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 2 November 2022, the WHO announced that the mpox (monkeypox) outbreak was still a global health emergency at the highest alert level on the Public Health Emergency of International Concern (PHEIC). 1651 The Australian government advised citizens that those not affected severely by monkeypox only require pain relief, but those with severe symptoms may need antiviral treatments. The Australian government advises vaccinations to the disease beforehand.

On 6 January 2023, Australia, as a Co-Chair of the Agile Member States Task Group on Strengthening WHO's Budgetary, Programmatic and Financing Governance, prepared a report with recommendations for reform and presented it to the WHO Executive Board. 1652

On 15 February 2023, Australia promised to send an additional AUD8 million in aid to Türkiye and Syria, increasing its total contribution to the nations to AUD18 million. 1653 The money will be sent through Australian nongovernmental organizations and the United Nations Population Fund to deliver aid to

protect the most vulnerable. This demonstrates Australia's commitment towards strengthening the resilience of global health systems.

On 21 February 2023, the Department of Health and Aged Care announced a commitment to deliver a National Strategy to Achieve Gender Equality in healthcare. Australia identified important health disparities between men and women, especially for women and girls in the First Nations, LGBTIQ+, and refugee communities. The Australian Government places the address of sex and gender differences in the health system a high priority.

On 23 February 2023, the Australian Global Health Alliance and Pacific Friends of Global Health endorsed Australia's renewed effort to help build resilient and equitable health systems in the Pacific and Southeast Asia. 1655 Australia pledged a AUD620 million package known as the Partnerships for a Healthy Region. Under the initiative, Australia will support partner countries to reduce disease risks, burdens and respond effectively to health emergencies.

On 13 April 2023, Australia and the United States provided Indonesia with a shipment of new oral antiviral medicine (PAXLOVID) to treat COVID-19 patients through WHO.¹⁶⁵⁶ The sharing of medicine demonstrates the partnership and value of collaboration between the three countries.

On 27 April 2023, Professor Margaret Hellard, Deputy Director in the Department of Infectious Diseases at the Alfred Hospital in Melbourne, co-chaired a presentation about viral hepatitis elimination at the 18th Global Hepatitis Summit. The summit was an opportunity for people to share latest developments and research and promote ways to control and eliminate liver disease. Professor Hellard addressed the global perspective and discussed what was missing in WHO guidance, promoting next steps such as easier service delivery for people with hepatitis B and C.

On 2 May 2023, Australia awarded over AUD1.5 million to a project led by Monash University's Professor Helena Teed, which aims to improve equity and advance female representation in healthcare leadership. According to a 2019 WHO report, women accounted for 70% of the global health workforce, but remained under-represented and segregated into lower-status jobs in the sector. Through their project, Professor Teede and her team emphasized the importance of women's equity in healthcare, and with the grant, will create an implementation toolkit for improvement and advancements in equity for all in healthcare.

On 11 May 2023, the Australian Broadcasting Corporation broadcasted the announcement from the WHO stating that mpox was no longer a global health emergency. 1659

On 12 June 2023, Mitchell Field, the Representative of Australia to the UN, emphasized the need for more to be done with tackling HIV/AIDS and bringing it down from a global crisis. ¹⁶⁶⁰ Field also highlighted the Australian government's global and domestic efforts to reduce transition and provide effective treatment.

On 13 June 2023, a report from Gavi, the Vaccine Alliance, which is a public-private partnership including governments, the WHO, and the World Bank, announced that it is projected to vaccinate 1 billion children by 2025 from diseases such as polio, tetanus, hepatitis B, and haemophilus influenzae, saving approximately 17 million lives. A donor since 2006, Australia is Gavi's second largest donor and supporter through their contribution to immunology and vaccine development in global public health of Gavi's work.

On 10 July 2023, it was announced that the World Organization of National Colleges, Academies and Academic Associations of General Practitioners/Family Physicians World Conference will take place in Sydney, Australia in 2023. 1663 It will be hosted by the Royal Australian College of General Practitioners and gather members in primary care to meet and tackle key issues.

On 29 July 2023, in a joint statement on Australia-U.S. Ministerial Consultations 2023, the two governments released a statement which acknowledged many principles they discussed, including the increase of health security in the Indo-Pacific.¹⁶⁶⁴

On 1 August 2023, it was reported that Australian Ambassador to Korea Catherine Raper, met with Korea's Minister of Health and Welfare Cho Kyoo Hong, to talk about cooperation in the health and welfare sector. At the meeting, Minister Cho also emphasized the importance of international cooperation to achieve better health security.¹⁶⁶⁵

Australia has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. However, there has been no action aimed at emphasizing the role of WHO has provided aid to global health projects and taken limited actions to promote international cooperation on health policy.

Thus, Australia receives a score of 0.

Brazil: +1

Brazil has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 7 December 2022, the Ministry of Health carried out the certification of municipalities that have successfully eradicated HIV and/or syphilis transmission in accordance with the requirements of the Pan

American Health Organization and WHO in order to create a more resilient network in Brazil's Unified Health System. 1666

On 7 December 2022, the Ministry of Health added a new drug, a mixture of sofosbuvir, velpatasvir and voxilaprevir, for use in chronic hepatitis C treatment. The addition aligns with WHO's recommendations for the retreatment of those with chronic hepatitis C treatment and follows the national approval process.

On 27 December 2023, the Ministry of Health announced BRL15 million in funding towards the development of medical devices in partnership with the Brazilian Company of Industrial Research. The aim is to bolster Brazil's health supply chain and innovation.

On 6 January 2023, the Ministry of Science, Technology and Innovation's Rede Corona-Ômica released a report outlining the spread of the coronavirus in Brazil from 14 November 2022 to 1 January 2023. The report was based on genomic sequencing and provided valuable data, which was shared publicly through the Global Initiative on Sharing Avian Influenza Data.

On 23 January 2023, the Ministry of Health officiated their aim for bilateral collaboration with Argentina's Ministry of Health to improve health. ¹⁶⁷⁰ The collaboration would include matters of gender and cultural equity in health care, the economic-industrial complex, and knowledge exchange among other issues.

On 30 January 2023, Secretary of Science, Technology, Innovation and Health Complex Carlos Gadelha declared that Brazil would bring forward a resolution of Indigenous peoples' health to the World Health Assembly. He highlighted the shortcomings of the public sector in ensuring the health of Indigenous children and sustainable development.

On 6 February 2023, the Ministry of Health officiated the National Policy for Reducing Queues for Elective Surgery. A total of BRL600 million in funding will go towards the cause. In support of the initiative, President Luiz Inácio Lula da Silva highlighted the importance of universal health care.

On 6 February 2023, the Ministry of Health announced that the Global Community of Sustainable Technology and Innovation would hold their annual meeting in Brazil. 1673 With the UN 2030 Agenda at

the forefront, the focus is to promote technology-based solutions in a post-COVID-19 world, including in the area of health.

On 9 February 2023, the Ministry of Health declared the arrival of their donations of medicine and health supplies to Türkiye by 9 February 2023.¹⁶⁷⁴ They anticipate that a maximum of 4, 500 people could benefit from the donations over a month.

On 16 February 2023, Secretary of Information and Digital Health Ana Estela Haddad publicized a proposal for a Laboratory of Innovation and Digital Health at the Ministry of Health. 1675 The goal of the project is "to create an integrated network to foster innovation in the Unified Health System."

On 16 February 2023, the 2nd Ordinary Meeting of the Tripartite Intermanagers Commission 2023 declared that from March onward, COVID-19 data updates would occur weekly rather than daily. ¹⁶⁷⁶ The actions result from inconsistent data entry with the daily approach, with the aim of improving surveillance processes.

On 27 February 2023, the Ministry of Health inaugurated its National Movement for Vaccination. The movement possesses multiple stages, beginning with double COVID-19 booster doses in high-risk populations. The second stage will encourage COVID-19 vaccination in the general population. The subsequent stages focus on influenza and upgrading the vaccination booklet. Following decreased vaccination, the aim is to restore Brazil's exemplary record. The movement aligns with WHO's directives.

On 13 March 2023, Brazil joined the Global Outbreak Alert and Response Network (GOARN), which is an international group affiliated to the WHO.¹⁶⁷⁷ In response, Director Marcio Garcia stated, "Our entry into GOARN is also a statement of the Ministry of Health's commitment to the international community in protecting the global public health and safety of citizens of all countries." Through its participation, Brazil's Ministry of Health will contribute to effective responses against epidemics.

On 14 March 2023, the Secretary for Strategic Policies and Programs of the Ministry of Science, Technology and Innovation Marcia Barbosa asserted development and manufacturing efforts for active pharmaceutical ingredients (API).¹⁶⁷⁸ The aim is to promote Brazil's self-reliance with respect to their API supply, building on efforts by the Pró-IFA Network that began in November 2022.

On 22 March 2023, Minister Trindade and the Secretary of State for Health Promotion of Portugal Margarida Tavares signed a letter of intent, delineating agreed upon health-related goals. The goals include collaboration in digital health, greater vaccine capacity, and accessible primary health care. Furthermore, a memorandum was signed by the countries that focuses on collaboration in biomedical research.

On 23 May 2023, the Ministry of Health announced that it had contributed to amendments to the International Health Regulations, which was originally accepted by the WHO in 2005. The Regulations aim to stop the circulation of diseases globally. The revised document added public health emergencies and better information exchange systems among other changes.

On 24 May 2023, Brazil submitted a resolution on indigenous health with the support of thirteen countries and the European Union at the World Health Assembly. Specifically, the resolution highlights indigenous health in the WHO agenda and calls for global action through respect for traditional medicine for instance. The aim is for the signatories to exchange ideas on the subject and construct national plans guided by the resolution's points of action.

On 25 May 2023, the Permanent Mission of Brazil co-led an event on childhood immunization at the World Health Assembly. They highlighted the need to continue and improve child immunization, especially with declining vaccination rates in Brazil since 2015.

'On 6 June 2023, Brazil inaugurated the Global Council on Inequalities, AIDS, and Pandemics, which it founded with a focus on the role of socioeconomic factors during pandemics and on countering global health emergencies. The council's membership includes UNAIDS Executive Director and UN Under-Secretary-General Winnie Byanyima. The aim of the council is to encourage international cooperation to improve health systems to effectively grapple with health crises to come, with a focus on policy making.

Brazil has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. Brazil has committed to expanding the accessibility to new health care products. Despite previous shortcomings in the Covid-19 vaccine supply chain, Brazil has taken strides to address distribution issues and promote immunization, and to further universal health care under its Unified Health System, which aligns with the Sustainable Development Goal of Universal Health Coverage. It has demonstrated ongoing evaluation of its health care processes and has engaged in some international collaboration. Brazil recognizes and is addressing the current crisis in Yanomami.

Thus, Brazil receives a score of +1.

Canada: +1

Canada has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 1 December 2022, Prime Minister Justin Trudeau inaugurated the interim Canada Dental Benefit for families with kids younger than 12 without private dental insurance. To be eligible, annual adjusted family net income must be lower than CAD90,000. The benefit delivers a direct, non-taxable amount of CAD650 for each child annually and a maximal amount of CAD1,300 in the upcoming two years. The aim of this benefit is to reduce the financial burden of families, thereby increasing accessibility to oral healthcare.

On 13 January 2023, Minister of International Development and Minister responsible for the Pacific Economic Development Agency Harjit S. Sajjan declared CAD45 million in funding aimed at the Latin America and Caribbean Region through the Pan-American Health Organization (PAHO), in addition to CAD70 million to the United Nations Children's Fund (UNICEF). The goal of this funding is to support Canada's Global Initiative for Vaccine Equity, thereby improving post-Covid-19 global health systems. By working with PAHO, Canada strives to improve Covid-19 vaccination accessibility in the Americas.

On 27 January 2023, Minister Sajjan declared CAD28.5 million in financial support for development projects in Jordan. 1686 Among the development-related areas this assistance will go towards are health services aimed at refugees.

On 7 February 2023, Canada declared that it would raise provincial and territorial health investments by CAD196.1 billion throughout 10 years by investing CAD46.2 billion. Over 10 years, CAD25 billion will be invested on: family health services, backlogs, mental health and substance use, and an improved health system. To address equitable health care for Indigenous peoples, CAD2 billion will be invested across 10 years.

On 16 February 2023, Prime Minister Justin Trudeau announced a CAD 12.3 million investment to improve various developmental targets, including general and sexual reproductive healthcare needs for women and girls, as well as water, sanitation and hygiene to combat cholera. Further, he pledged CAD1.8 million towards causes including the opioid crisis and CAD11.48 million towards Maternal, Newborn and Child Health services aimed at Indigenous populations in the hinterland. These investment pledges follow Prime Minister Trudeau's trip to Nassau focusing on Canada's relationship with the Caribbean and improving the Haiti crisis.

On 24 February 2023, Minister Sajjan declared a further CAD20 million in humanitarian support for earthquake-stricken regions of Türkiye and Syria as well as the matching of CAD10 million donated to the Humanitarian Coalition and its members. Through this financial support, the Humanitarian Coalition and its members will provide necessary services including health care.

On 27 February 2023, Minister Sajjan declared a CAD46 million investment in 2023 for those devastated by the crisis in Yemen. ¹⁶⁸⁹ United Nations agencies, Red Cross' International Committee, and other non-governmental organizations will be the recipients of the investment in order to access good nutrition, healthcare, clean water and sanitation.

On 8 March 2023, Minister Sajjan reported CAD157.6 million in funding towards various initiatives in Bangladesh and other underdeveloped countries. Bangladesh would receive CAD98.6 million for projects that include sexual and reproductive health and rights and humanitarian and health services for refugees."

On 16 March 2023, on behalf of Minister of Innovation, Science, and Industry François-Philippe Champagne and Minister of Canadian Heritage Pablo Rodriguez announced a CAD23.8 million investment towards Jubilant HollisterStier's CAD108.3 million project under the Strategic Innovation Fund, thereby aiming to build vaccine capacity. The goal is to improve Canada's domestic vaccine manufacturing.

On 22 March 2023, Minister Duclos announced up to CAD1.5 billion in funding over a three-year period under the National Strategy for Drugs for Rare Diseases. ¹⁶⁹² The goal of the consultation-driven investment is to lower the cost and availability of drugs for rare diseases. Moreover, another CAD68 million will contribute to the accessibility of drugs for rare diseases through supporting evidence collection, diagnostic research, and implementing governance structures among other areas.

On 20 April 2023, Global Affairs Canada's Director General for Southern and Eastern Africa Caroline Delany asserted Canada's ongoing support for the mRNA Technology Transfer Programme with an additional CAD15 million investment. The mRNA Technology Transfer Programme is a collaborative project that was initiated by the WHO and Medicines Patent Pool in 2021 in order to increase accessibility to vaccines and other medical products globally. The investment will aid capacity-building in South Africa and other global partners.

On 25 April 2023, Minister of International Trade, Export Promotion, Small Business and Economic Development Mary Ng declared that CAD50 million of funding will be going towards six Life Sciences venture capital funds. 1694 As part of the renewed Venture Capital Catalyst Initiative, this investment will drive innovation in the health space.

On 26 April 2023, Minister Duclos and Minister Sajjan declared over CAD100 million in funding towards the Coalition for Epidemic Preparedness Innovations (CEPI), which involves international collaboration. The funding will go towards CEPI's five-year strategic plan, which aims to quicken the development of vaccines and increase their accessibility. Moreover, CAD2.7 million will fund Canadian researchers studying epidemics and pandemics.

On 3 May 2023, Minister Sajjan declared the dissemination of CAD71 million of funding towards Sudan, South Sudan, and the Central African Republic. 1696 The funding was disseminated to the UN and Red Cross among other non-govenrmental organizations and will go towards health services among other areas affected by their humanitarian crisis.

On 4 May 2023, the Public Health Agency of Canada collaborated with WHO and the International Institute for Sustainable Development on a report called, "A framework for the quantification and economic valuation of health outcomes originating from health and non-health climate change mitigation

and adaptation action." ¹⁶⁹⁷ It puts forward a framework evaluating the effect of investments addressing climate change on health.

On 11 May 2023, Minister Duclos announced CAD6.3 million in new funding towards Combatting Antibiotic-Resistant Bacteria Biopharmaceutical Accelerator, which works on problems related to antibiotic resistance. Part of the goal of this investment is to bolster innovation related to antimicrobial drugs around the world.

On 24 May 2023, Minister Sajjan declared that CAD58.1 million would be provided for humanitarian aid, including health care, for Ethiopia and Somalia amidst their climate crisis. 1699 UN agencies, the International Committee of the Red Cross and other non-governmental organizations are the recipients of this funding.

On 24 May 2023, on behalf of Minister Duclos, Member of Parliament for Don Valley West Rob Oliphant declared CAD6.35 million of funding towards thirteen Canadian teams conducting research on monkeypox and other zoonotic diseases.¹⁷⁰⁰ This investment will help prepare for future outbreaks and will also contribute to improved global health outcomes.

On 31 May 2023, Minister for Mental Health and Addictions and Associate Minister of Health Carolyn Bennett declared that Canada will be the first country globally with mandatory health warnings on individual cigarettes beginning. The announcement took place during World Tobacco Day, which had been introduced in 1987 by WHO member states. Packaging and Labeling Regulations, the goal is to reduce the burden of smoking, with the enactment beginning in August 2023. August 2023. August 2023.

Canada has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. Canada has committed to significant investments aimed at enhancing the domestic health care system. Further, it has taken action to make healthcare more accessible to Canadians, thereby furthering the Sustainable Development Goal 3. Finally, Canada has pledged significant financial resources towards bettering health care in countries with underdeveloped health care systems. In doing so, Canada has made strides to collaborate with several international organizations in addition to WHO.

Thus, Canada receives a score of +1.

China: +1

China has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 26 November 2022, the 19th World Congress of Chinese Medicine was held in Brazil.¹⁷⁰⁴ The intention of the meeting was to promote the high-quality development of Chinese medicine globally and work towards global health and well-being.

On 30 December 2023, the National Health Commission (NHC) and National Disease Control and Prevention Administration briefed the WHO on China's current Covid-19 policies. These policies pertained to issues such as clinical care, epidemiology and vaccination.

On 1 December 2022, China sent a medical team to the Solomon Islands to provide free medical care for those in need.¹⁷⁰⁶ The Chinese team also provided medical training to local doctors which built up the capacity of local staff.

On 9 December 2023, the NHC briefed the WHO on China's current Covid-19 policies.¹⁷⁰⁷ NHC spokesperson Mi Feng noted that China is willing to work with WHO and the international community to end the Covid-19 pandemic.

On 5 January 2023, China attended an online briefing held by the WHO regarding Covid-19. The introduced its own policies for Covid-19 and discussed its views with other WHO member states.

On 11 January 2023, Foreign Minister Qin Gang delivered a speech at the Completion Ceremony for the Africa Center for Disease Control and Prevention Headquarters, a building project organized by China. Minister Qin emphasized China's continued commitment to collaborating with the African Union to advance global health governance.

On 13 January 2023, NHC spokesperson Mi Feng affirmed that China has led the global fight against Covid-19.¹⁷¹⁰ Mr. Mi highlighted China's efforts to share information, donate supplies, and contribute to policy regarding Covid-19.

On 14 January 2023, Head of the NHC Ma Xiaowei and WHO Director General Dr. Tedros Adhanom Ghebreyesus met to discuss the Covid-19 situation in China. Mr. Ma provided the WHO with information which will allow the WHO to obtain a stronger understanding of the conditions in China.

On 27 January 2023, China donated reproductive health supplies and personal protective equipment to Botswana, in partnership with the United Nations Population Fund.¹⁷¹²

On 10 February 2023, China sent shipments of medicine and medical supplies to areas affected by the earthquake in Syria and Türkiye.¹⁷¹³

On 16 February 2023, China organized a medical camp in central Uganda to provide free medical care for those in need.¹⁷¹⁴ This medical camp aimed to provide healthcare to remote areas of Uganda.

On 23 February 2023, Consultant of the Chinese delegation for the WHO Executive Board Yangmu Huang participated in a WHO webinar regarding global health governance on generic medicines.¹⁷¹⁵ Mr. Huang discussed Chinese policy regarding the use of quality-assured generic medicines.

On 25 February 2023, China sent a medical team to Togo to provide free medical consultation for those in need.¹⁷¹⁶ The Chinese team assisted over 600 patients and donated supplies to a local medical centre.

On 6 March 2023, Deputy Director of the Information Department of the Ministry of Foreign Affairs Mao Ning encouraged WHO to call on the United States to end the politicization of Covid-19 origins tracing. Deputy Director Mao argued that such politicization is only working to "undermine the global health governance mechanism."

On 11 May 2023, the China International Development Cooperation Agency released a report titled International Development Cooperation: China's Practice. The report details China's numerous international efforts to combat Covid-19, illustrating the country's dedication to global health.

On 16 May 2023, Chinese Ambassador to Mauritania Li Bojun attended a medal-conferring ceremony recognizing the 34th batch of the Chinese medical aid team in Mauritania. ¹⁷¹⁹ Li noted that China-Mauritania cooperation regarding public health will continue.

On 17 May 2023, the Hong Kong Special Administrative Region government held the third Asia Summit on Global Health. This summit sought to bring together global health experts and focused specifically on the future of healthcare.

On 22 May 2023, China lobbied WHO member states to reject Taiwan's request for an invitation to the World Health Assembly (WHA).¹⁷²¹ China's efforts succeeded, and Taiwan's request was rejected. Taiwan's exclusion from the WHA hinders its ability to collaborate in global health efforts and puts the health of the island's citizens at risk.

On 25 May 2023, Vice-Minister of the National Health Commission Cao Xuetao attended the 76th WHA.¹⁷²² Cao expressed China's firm commitment to collaborating with the international community to improve public health.

On 6 June 2023, Minister Ma announced China's commitment to increasing its foreign medical aid. 1723 These comments were made in an article published on the 60th anniversary of China sending its first medical team abroad to Algeria.

On 20 June 2023, Prime Minister Li Qiang met with German Federal Chancellor Olaf Scholz in Berlin to discuss global challenges, including global health policy. 1724 Chancellor Scholz emphasized the importance of Sino-German cooperation in the health sphere, especially surrounding the WHO.

China has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. It has engaged with many partners by providing medical aid and personnel, and repeatedly cooperated with the WHO through sharing information and combining efforts.

Thus, China receives a score of +1.

France: 0

France has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 1 December 2022, France reiterated its commitment in the global fight against HIV/AIDS.¹⁷²⁵ France reaffirmed the need to strengthen the French National Health or the Couverture Maladie Universelle (CMU) for improved health governance. France also called on members of the international community to increase efforts to end the HIV/AIDS epidemic by 2030.

On 12 December 2022, the WHO announced that France had developed an advanced national infection prevention and control (IPC) program which incorporates WHO recommended core components. This program also involves the Ministry of Health and Prevention, French national and regional health authorities and other ministries who were tasked to develop France's new National Strategy for Preventing Infections and Antibiotic Resistance (2022-2025). This program stresses the importance of the equal promotion of measures for IPC and antimicrobial leadership, the broad scope of IPC, and the implementation of the strategy at all levels with particular emphasis at the local level.

On 28 December 2022, the Permanent Mission of France to the United Nations in New York announced that France had gone beyond its commitment to donate 120 million Covid-19 vaccine doses to the Covid-19 Vaccines Global Access (COVAX) Facility. The COVAX Facility distributes Covid-19 vaccines to COVAX-participating countries as quickly, fairly and safely as possible. France's annual allocation reached

almost 50 per cent of donations to Africa and 40 per cent to South- and South-East Asia, targeting the most vulnerable countries with the most dilapidated health systems.

On 20 February 2023, Minister of State for Development, Francophonie and International Partnerships Chrysoula Zacharopoulou visited the Pasteur Institute to discuss "global health challenges, preparation for future pandemics and international cooperation on health and research." Minister Zacharopoulou also welcomed the announcement that the Pasteur Institute would loan its scientific ad research acumen from the Emergency Biological Intervention Unit to Türkiye with the aim of detecting infectious diseases and to provide diagnoses for local populations. The group will carry out this three-month task under the mandate of WHO.

On 25 April 2023, France reaffirmed its global commitment towards defeating malaria by 2030.¹⁷²⁹ France called upon its partners to renew efforts regarding actions such as research funding, disease diagnosis and treatment to reach their goal by 2030.

On 16 May 2023, President Emmanuel Macron visited the Curie Institute and announced new measures regarding their 2030 Health Innovation Plan. ¹⁷³⁰ President Macron declared they would be supporting 10 new university hospital institutes in Bordeaux with EUR20 million to EUR40 million for all projects, providing EUR300 million toward projects on inflammatory bowel and age-related diseases, and EUR400 million toward creating five bioclusters. The goal is to boost health innovation and biomedical research in France.

France has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. France has cooperated with WHO recommendations for the Covid-19 pandemic, infection prevention and control and to provide aid to local populations in Türkiye. It has also collaborated with international governance efforts such as COVAX, a corollary of WHO. However, it has not taken substantive actions towards incorporating the role of other international organizations.

Thus, France receives a score of 0.

Germany: +1

Germany has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 17 November 2022, the Federal Ministry for Economic Cooperation and Development announced that it will support Tanzania with introducing a health insurance scheme. Germany committed over EUR87 million to this cause, which will make a significant impact towards ensuring that Tanzanians receive quality healthcare.

On 18 November 2022, the Federal Foreign Office and Federal Ministry of Health announced EUR2.5 million in aid for the Ukrainian rescue service. This will specifically involve the rebuilding of a rescue bus allowing for medical-related evacuations from Ukraine.

On 9 December 2022, Federal Health Minister Professor Karl Lauterbach delivered a lecture at Harvard University in the United States. ¹⁷³³ Minister Lauterbach reaffirmed Germany's commitment to global health policy and continued dialogue with the United States.

On 20 December 2022, the Federal Ministry of Health published a paper outlining a legislative package regarding European drug shortages.¹⁷³⁴ The proposed legislation will fight drug shortages by working to strengthen the European Union as a drug producer.

On 22 December 2022, Germany accepted into its care 11 Ukrainian children who required palliative care. 1735 These children were welcomed into various German medical facilities and are now receiving care from German doctors.

On 22 January 2023, Minister Lauterbach and French Minister of Health François Braun made commitments to collaborate on multiple public health projects. The countries will work together to provide citizens with access to high-quality healthcare, and increase access to health data via digital health policies. They will also collaborate to strengthen public and global health cooperation in Europe more generally.

On 3 February 2023, the Federal Ministry of Health announced a contribution of EUR 130 million to the WHO.¹⁷³⁷ This contribution will support the WHO in various areas of priority, and makes Germany the top donor to the WHO's Contingency Fund for Emergencies.

On 14 February 2023, Germany provided funding to a WHO health mission in Ukraine focused on nuclear emergencies.¹⁷³⁸ The mission trained Ukrainian first responders on how to care for patients and which medicine to administer in the case of a possible nuclear attack on Ukraine.

On 18 March 2023, Germany provided funding to a WHO interregional meeting regarding the health of migrants and refugees. This second meeting sought to commence the implementation of strategies introduced at the first meeting. The meeting focused primarily on migrants and refugees in the East Mediterranean, as well as Africa and Europe more generally.

On 21 March 2023, Germany organized the Friends of Global Health Meeting. 1740 This meeting brought together multiple member states of the WHO to discuss key global health issues, one being climate change.

On 24 March 2023, Germany and the Netherlands launched a joint initiative regarding climate-resilient water utilities throughout the Global South.¹⁷⁴¹ This initiative seeks to support growing cities in the Global South by providing them with resources to improve their water infrastructure. Germany is providing EUR32 million to this initiative.

On 20 April 2023, Germany supported the opening of an mRNA technology hub in South Africa with EUR5.3 million.¹⁷⁴² This hub is meant to develop mRNA vaccines to be shared with surrounding African countries.

On 20 June 2023, Federal Chancellor Olaf Scholz met with Chinese Prime Minister Li Oiang in Berlin to discuss global challenges, including global health policy.¹⁷⁴³ Chancellor Scholz emphasized the importance of Sino-German cooperation in the health sphere, especially surrounding the WHO.

Germany has fully complied with its commitment to strengthen global health governance by engaging with the WHO and other international allies. It has provided aid to multiple global health projects and took actions to promote international cooperation on health policy.

Thus, Germany receives a score of +1.

India: +1

India has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 22 November 2022, the Ministry of Ayush announced the creation of an Ayurveda Academic Chair at Australia's Western Sydney University's NICM Health Research Institute. 1744 This action is meant to strengthen global health scientific and academic research collaboration between India and Australia.

On 5 December 2022, Minister Mandaviya met with Melinda Gates of the Bill & Melinda Gates Foundation.¹⁷⁴⁵ The two discussed continued collaboration on health priorities, Indian health sector reform and digital information integration, the potential of Indian medical manufacturing for global health and possibilities for leveraging India's G20 presidency in the interests of promoting public health.

On 22 December 2022, the National Health Authority announced the Digital Health Incentive Scheme (DHIS) initiative to promote the Ayushman Bharat Digital Mission (ABDM) by offering up to

INR40,000,000 in incentives to health facilities and digital solutions companies.¹⁷⁴⁶ This scheme, by offering rewards for the creation and linking of health records to the digital Ayushman Bharat Health Account service, seeks to further digital public health data integration in India.

On 22 December 2022, the National Health Authority in collaboration with the Bill & Melinda Gates Foundation and PricewaterhouseCoopers LLP India held a workshop on the ABDM for medical stakeholders.¹⁷⁴⁷ This workshop aimed to promote the ABDM and DHIS as well as highlight the importance and accessibility benefits of patient digital health record integration.

On 27 December 2022, the Central Drugs Standard Control Organization began conducting nationwide joint inspections on drug manufacturing units.¹⁷⁴⁸ These inspections ensure the safety, efficacy and quality of Indian produced drugs through enforcing drug regulation policy.

On 28 December 2022, the Union Ministry of Health and Family Welfare signed a memorandum of understanding with the Indian Oil Corporation on addressing tuberculosis in the states of Uttar Pradesh and Chhattisgarh.¹⁷⁴⁹ Through this memorandum, Indian Oil committed to supporting and providing resources to ongoing state efforts and initiatives for the elimination of tuberculosis.

On 13 January 2023, Minister Mandaviya chaired the health session of the 2023 Voice of the Global South Summit. ¹⁷⁵⁰ During the session, participants from multiple countries discussed global health cooperation to build resilient healthcare systems and the Minister offered Co-Win, a digital Covid-19 vaccination registration platform, to the WHO Covid-19 Technology Access Pool.

On 18 January 2023, the Ministry of Ayush hosted a visit from a Canadian delegation led by Ontario Minister of Mental Health and Addictions Michael Tibollo to the All-India Institute of Ayurveda in Delhi. This visit facilitated increased collaboration and adoption between India and Canada on traditional healthcare-based solutions.

On 26 January 2023, Minister Mandaviya unveiled the iNNCOVACC COVID19.¹⁷⁵² This vaccine is the world's first primary two-dose schedule approved intranasal Covid-19 vaccine and is meant to be affordable and easily distributed to fit the needs of the developing world.

On 3 February 2023, the Government announced the creation of the State Haemoglobinopathy Mission to eliminate sickle cell anemia by 2047.¹⁷⁵³ This initiative is meant to manage and reduce the harm to public health caused by sickle cell anemia.

On 23 February 2023, the Government collaborated with WHO and the United States Centre for Disease Control and Prevention to organize a three-day southeast Asia regional epidemiology training program.¹⁷⁵⁴ This program is meant to share public health experience in the field of epidemiology and build skill among medical professionals from countries in the region.

On 24 February 2023, Minister Mandaviya met with foreign delegates from almost 100 countries for the improvement of global pharmaceutical drug accessibility.¹⁷⁵⁵ During the conference, the delegations discussed collaboration for "procurement, research, skill development, pharmaceutical production in their own countries."

On 2 March 2023, the Union Ministry of Health and Family Welfare and the World Bank Pandemic Fund organized a seminar on the Pandemic Fund. The seminar covered the functioning of the Pandemic Fund and initial proposals as well as the role India could take in collaborating and implementing Pandemic Fund public health initiatives.

On 10 March 2023, the Union Ministry of Health and Family Welfare collaborated with WHO and the non-profit Centre for Global Development to organize the International Symposium on Health Technology Assessment (HTA).¹⁷⁵⁷ The conference provided a platform for stakeholders to discuss HTA and its international uses in constructing health governance systems, as well as hold a HTA marketplace.

On 20 March 2023, the Union Ministry of Health and Family Welfare collaborated with the WHO South-East Asia Regional office to hold a two-day international conference on digital health. The conference brought together global leaders and health governance partners to brainstorm an action plan on digital health initiatives for member countries.

On 24 March 2023, the Union Ministry of Health and Family Welfare collaborated with the Stop TB Partnership to organize the One World TB Summit 2023.¹⁷⁵⁹ The summit invited state officials, global representatives from the private sphere, non-governmental organizations and civil society to discuss the current progress of the programme to eliminate tuberculosis by 2025 and successful Indian policy initiatives and teachings that can be shared with other countries.

On 4 April 2023, the Union Ministry of Health and Family Welfare and the Directorate of Health Services for the Government of Goa, in partnership with the United Nations Children's Fund (UNICEF), held a tour to showcase cutting-edge health facilities and innovations. This event was part of the leadup to the second G20 Health Working Group Meeting and meant to demonstrate the benefits of digital healthcare integration, an initiative particularly spearheaded by India during its 2023 G20 Presidency.

On 16 April 2023, the Union Ministry of Health and Family Welfare, in collaboration with the Confederate of Indian Industry, held the 2023 Digital Health Summit. This international summit aimed to promote one of the leading items in India's G20 Presidency agenda and advances global collaboration on digital health integration as interoperability of adopted technologies.

On 24 April 2023, the Ministry of Health and Family Welfare, in partnership with the Asia Pacific Leaders Malaria Alliance, organized the Asia-Pacific Leaders' Conclave on Malaria Elimination in New Delhi. 1762 During the conference leaders from the Asia-Pacific gathered to discuss regional cooperation and efforts for the elimination of malaria by 2030.

On 26 April 2023, India hosted the 6th summit of Advantage Healthcare India 2023 in New Delhi. ¹⁷⁶³ This conference brought together global and industry leaders as well as international organizations to share their knowledge and collaborate on building resilient global health architectures.

On 10 May 2023, the Ministry of Health and Family Welfare launched the Stimulating Advanced Knowledge for Sustainable Health Management (SAKSHAM) management information system.¹⁷⁶⁴ SAKSHAM is a digital learning platform meant to provide uniform online training for healthcare professionals and providers across the country.

On 13 May 2023, Minister Mandaviya attended the G7 Health Ministerial Meeting in Nagasaki, Japan. ¹⁷⁶⁵ During the meeting, participants discussed implementation and utilization of health innovations as well as ways the global health system could cooperatively manage and address global health emergencies.

On 15 May 2023, Minister Mandaviya met with representatives from the Japanese pharmaceutical industry. This gathering was intended to help discuss ways Japanese companies could invest in India's pharmaceutical market and collaborate on research and innovation. 1766

On 24 May 2023, Minister Mandaviya attended the 76th session of the World Health Assembly. 1767 During the assembly, attendants collaborated on global health governance through working towards the WHO agenda goal of "Health for All."

On 4 June 2023, the Union Minister of State for Health and Family Welfare Bharati Pawar led the Indian delegation of the 3rd Health Working Group Meeting of India's G20 Presidency. The meeting focused on and stressed the importance of multilateral pandemic partnerships and strengthening global health architecture.

On 20 June 2023, the Union Ministry of Health and Family Welfare, in conjunction with the international Partnership for Maternal, Newborn and Child Health inaugurated a G20 co-branded gathering on youth

health.¹⁷⁶⁹ Delegates from various partner NGOs and agencies met to foster increased investment in empowering and meeting the needs of adolescents and youth worldwide.

On 1 July 2023, India launched the National Sickle Cell Anaemia Elimination Mission.¹⁷⁷⁰ This initiative aims to end the disease within the country by 2047 through the reduction of transmission by providing citizens with early diagnosis screening and intervention.

On 20 July 2023, the Ministry of Ayush hosted a conference in New Delhi between India and the Association of Southeast Asian Nations.¹⁷⁷¹ This conference aimed to provide a platform to discuss ways to advance traditional medicine systems and how they could aid in the attainment of Sustainable Development Goals.

On 20 July 2023, New Delhi hosted the first G20 Global Food Regulators Summit.¹⁷⁷² During the event, representatives from 30 international organizations and 25 research institutes met to discuss and deliberate on global standards for food safety.

On 25 July 2023, the Central Drugs Standard Control Organization and the Union Ministry of Health and Family Welfare announced a response to WHO alerts against cough syrup exports from India. New measures were implemented to address international concerns and ensure the standard of products such as mandated lab certification before export.

On 5 August 2023, Union Health Minister Dr. Mansukh Mandaviya addressed the BRICS Health Minister's Meeting. 1774 During the meeting, Minister Mandaviya announced support for collaboration on integrated early warning systems, nuclear medicine, and the BRICS TB Research Network Initiative.

On 17 August 2023, the Ministry of Ayush in conjunction with the World Health Organization organized the inaugural Global Summit on Traditional Medicine. The summit aimed to serve as a platform for the potential of traditional medicine as an aid to achieving global health goals.

On 17 August 2023, the Government of India organized the inaugural India Medtech Expo.¹⁷⁷⁶ Running alongside the G20 Health Minister's Meeting, this event is meant to bring together international experts for discussion and share cutting-edge medical technologies with the world.

On 18 August 2023, the Government of India hosted the G20 Health Minister's Meeting in Gandhinagar. 1777 During the meeting, delegates met to discuss global cooperation on digital health, pharmaceutical solutions and measures to address and prevent health emergencies.

India has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. They have organized numerous seminars, conferences and programmes in collaboration with the WHO and other international organizations. India has also taken action to improve public health through various government initiatives and campaigns to promote digitization of data in the health sector and eliminate and mitigate disease.

Thus, India receives a score of +1.

Indonesia: +1

Indonesia has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 1 December 2022, it was reported that as the host of the G20 Summit, Indonesia, which has been playing an important role in global health diplomacy, had to play roles in ensuring and securing that the pandemic fund was put to good use and distributed to low and middle-income countries for various purposes such as disease surveillance and capacity building for critical health workforce.¹⁷⁷⁸

On 5 January 2023, the Ministry of Health programmed a new initiative and a thorough health system transformation for cancer and other illnesses. The Working in partnership with the University of New Mexico in the United States, Tata Memorial Centre in India and the University of Indonesia, the Health Ministry intends to improve cancer diagnosis and treatments. The country has participated in new programs such as the Extension for Community Healthcare Outcomes, an oncology nurse capacity building program and the Cancer Patient Navigation.

On 22 February 2023, Health Minister Budi Gunadi Sadikin announced plans to meet the Director General of WHO Dr. Tedros Ghebreyesus in upcoming May to discuss changing the status of Covid-19 in the country from pandemic to endemic.¹⁷⁸⁰ Minister Sadikin also issued a note regarding the need to align the plan with other countries that are also planning to impose the endemic status.

On 3 April 2023, Indonesia endorsed the digitalization of the health sector during its Association of Southeast Asian Nations (AESAN) chairmanship through the ASEAN Universal Verification Mechanism (AUVM) and the ASEAN Knowledge Management Platform, which have been used to check the validity of COVID-19 vaccination certificates.¹⁷⁸¹ The Ministry of Health proposed to expand the utilization of AUVM for other health certificates in collaboration with its G20 program, the Federated Public Trust Directory, which was adopted by WHO after Indonesia's presidency ended. Indonesia encourages all ASEAN countries to take part in the program, to make health sector data and information more accessible for ASEAN Secretariat and WHO.

On 13 April 2023, the Indonesian Ministry of Health received a shipment of new oral antiviral medicine (Paxlovid) to treat COVID-19 patients, which was funded by the American and Australian governments, through WHO.¹⁷⁸² The sharing of medicine demonstrates the partnership and value of collaboration between the three countries.

On 21 April 2023, Health Minister Budi Gunadi Sadikin stated that Indonesia was successful in finding 74 per cent of tuberculosis (TB) cases at the 36th Stop TB Boarding Meeting in Varanasi, India, which is held annually to discuss the progress of TB research and tracking in the world.¹⁷⁸³ Sadikin also believes that Indonesia could eliminate TB with their regulations and innovations.

On 1 May 2023, Indonesia stated their commitment towards overseeing achievements in three main pillars during their ASEAN chairmanship this year.¹⁷⁸⁴ Their second pillar, labeled the Epicentrum of Growth, focuses on improving health infrastructure in local areas through the One Health Initiative, which WHO supports, and improving welfare of people through better food and energy resilience. Indonesia's leadership in social and health development is expected to have a positive impact on the ASEAN communities in establishing a prosperous quality of life for citizens soon.

On 9 May 2023, Indonesia started to bring COVID-19 from a health emergency phase by getting coronavirus infections under control and Health Ministry Mohammed Syahril said that global citizens will need to prepare on living with COVID-19, because it could still exist for a long time, as explained by the WHO.¹⁷⁸⁵ The WHO has advised all countries to work on increasing their capacity to fight future pandemics or epidemics, which Indonesia is working on.

On 15 May 2023, the International Finance Corporation (IFC) and Indonesia Ministry of Health formed a new partnership to initiate the Indonesian Health Sector Growth Program.¹⁷⁸⁶ Their aim is to support health care organizations and companies in Indonesia and grow efforts to the resilience of the health care sector.

On 30 May 2023, it was reported that delegate nations at the 76th World Health Assembly focused discussion around ending tuberculosis (TB) by 2030.¹⁷⁸⁷ At the Strategic Roundtable on Ending TB by 2030 held on May 25, Mr Setiaji, Deputy Minister for Health Technology Indonesia, mentioned Indonesia's new innovative national health financing strategy, along with their commitment to TB vaccine development and research.

On 6 June 2023, the Ministry of Health ensured that the Health Bill, which is still in the process of being recognized, had health protection for Indonesian infants and children.¹⁷⁸⁸ This effort hopes to improve infant and children health, as well as growth and development and reducing sickness and death.

On 12 June 2023, Indonesia announced their serious commitment towards dealing with dengue fever in the Association of Southeast Asian Nations (ASEAN) region. ¹⁷⁸⁹ The government plans to bolster public awareness about the dangers of dengue for the Indonesians.

On 25 July 2023, the Indonesian Health Ministry announced that Wolbachia technology and dengue vaccines are main targets they hope to address at the 2023 ASEAN Dengue Day.¹⁷⁹⁰

On 26 July 2023, Director of Communicable Disease Prevention and Control at the Health Ministry Imran Pambudi said that Indonesia's focus is to eliminate hepatitis B and C by 2030, in response to the WHO's estimation of 296 million people worldwide living with chronic hepatitis B (HBV).¹⁷⁹¹ Based on figures, Indonesia is a country with a middle-to-high level of HBV endemicity, which the ministry plans to tackle through different interventions.

On 27 July 2023, Indonesia generated nine memoranda of understanding for cooperation with the private health sector in China about technology transfer for vaccine production and management of health information systems, during President Joko Widodo's visit to the country.¹⁷⁹²

On 7 August 2023, health ministers from the Asia-Pacific Economic Cooperation, including Indonesia, agreed to work on increasing investments toward public health and bolster primary health care systems to be stronger against pandemic prevention and response.¹⁷⁹³

Indonesia has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. By collaborating with WHO, as well as organizations such as ASEAN and UNICEF, Indonesia has emphasized the role of institutions in the international health system.

Thus, Indonesia receives a score of +1.

Italy: 0

Italy has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO)and support from other international organizations.

On 18 November 2022, Italy provided EUR185 million in funding to the Global Fund to Fight AIDS, Tuberculosis and Malaria, allowing the fund to reach USD15.7 billion in replenishments.¹⁷⁹⁴

On 5 April 2023, the Government agreed to provide PKR 500 million through the Benazir Income Support Programme to improve the health of children and women in the Baluchistan region. ¹⁷⁹⁵

Italy has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. It has engaged in bilateral health support and collaborated with the Global Fund to Fight AIDS, Tuberculosis and Malaria. However, it has not taken any actions to emphasize the role of WHO in global health governance.

Thus, Italy receives a score of 0.

Japan: 0

Japan has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 23 December 2022, Japan signed a USD6.3 million agreement with Haiti to help the nation improve health and security within its borders. Within this budget, USD3 million will be pledged toward improving the Haitian government in the reconstruction of its health infrastructure affected by the earthquake in August of 2021.

On 13 April 2023, 24 chief executive officers from the Biopharmaceutical CEO Roundtable (BCR) along with Prime Minister Fumio Kishida met in Japan to discuss the importance of strengthening global health innovation and developing Japan's leadership position in life sciences.¹⁷⁹⁷ The BCR also proposed the "Biopharmaceutical Industry Vision for Equitable access in Pandemics" which commits to receive vaccine production, treatments and testing during future pandemics to ensure proper allocation of resources to vulnerable and low income countries.

On 25 May 2023, Japan announced continued efforts toward global healthcare coverage in hopes of eliminating healthcare discrepancies between countries.¹⁷⁹⁸ In collaboration with the National Center for Global Health and Medicine (NCGM), which focuses on research and technology development for infectious diseases and various illnesses, the Japanese government continues to prioritize global health as an area for international cooperation.

On 25 May 2023, Eisai Co., a Japanese Public-Private corporation, pledged a five-year grant of JPY625 million to the Global Health Innovative Technology Fund. This grant is aimed toward helping people suffering from infectious diseases in developing countries, as well as establishing necessary local medical supply systems in emerging economies.

On 31 May 2023, Japan announced the establishment of a new disease control center in preparation for future infectious disease crises. ¹⁸⁰⁰ Through the integration of the National Institute of Infectious Diseases and the NCGM, the new organization will play a key role in infectious disease control as well as conduct clinical research and provide scientific knowledge to the government.

On 5 July 2023, the NCGM of Japan and BlueDot Inc. signed an agreement in which BlueDot's expertise in artificial intelligence will aid Japan in their commitment to improving response and resilience to infectious disease outbreaks. Through the use of BlueDot's infectious disease intelligence the NCGM will be able to identify emerging diseases and improve their risk management response time.

On 13 July 2023, Japan and the European Union held their 29th summit in Brussels in which they committed to enhancing health security. This commitment included the strengthening of health security

through plans to improve global health architecture, work toward universal healthcare coverage, and strengthening pandemic prevention and response.

Japan has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. With regard to strengthening global health governance, Japan has made financial contributions to send medical supplies to Syria. Since the Covid-19 pandemic, Syrian healthcare facilities have been struggling to provide adequate patient care; with the contribution of medical supplies, Japan is able to aid in the strengthening of Syria's patient care. Japan has also contributed financial aid to Haiti in hopes of improving their health and security sector and updating their infrastructure. However, Japan has not taken sufficient actions to engage WHO.

Thus, Japan receives a score of 0.

Korea: +1

Korea has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 29 November 2022, the Ministry of Food and Drug Safety was announced to have reached maturity level four, which is the highest level of WHO's classification of regulatory authorities when it comes to medical products. This was a milestone for Korea and the overall world because it illustrates that the Korean ministry holds the national regulatory authority for medicines and vaccines. Korea will continue to contribute to the global oversight of vaccines and medicines, while assisting other countries to do the same.

On 13 December 2022, Second Vice Minister of Foreign Affairs Lee Do Hoon met with Under Secretary of State of Economic Growth, Energy, and the Environment Jose W. Fernandez. 1804 They committed to continue supporting the Global Health Security Agenda, and signed the amended memorandum of understanding between the U.S. Department of Health and Human Services, built on the United States-Korea Global Vaccine Partnership and to explore opportunities for further collaboration to enhance production and access to vaccines and medical supplies on a global scale.

On 19 January 2023, President Yoon Suk Yeol delivered a special address at the World Economic Forum promising that Korea will play a leading role in facilitating international cooperation and solidarity, especially in the health sector. Korea also promised to continue to align themselves with universal health rules to work on global challenges.

On 7 February 2023, Minister of Health Jee Young Mee announced that Korea was considering lifting the remaining Covid-19 policies based on WHO's decision on the status of the disease. MHO ruled that Covid-19 still constituted a public health emergency of international concern on 30 January. Korea announced that it is preparing for the possibility of downgrading Covid-19's threat status, but it would only come after the WHO's declaration as no longer a global emergency.

On 15 March 2023, five cities were recognized for their public health achievements at the Partnership for Healthy Cities Summit held by WHO in London. Mayor Oh Se Hoon from Seoul was one member out of the more than 50 major city mayors and officials who were a part of the partnership and summit to discuss urgent public health concerns and best course of action to save lives on the global scale.

On 21 April 2023, the fourth biannual Global Vaccine and Immunization Research Forum was held inperson after four years at Incheon, South Korea. More than 450 participants from the world gathered to track progress in priority vaccine research and development and discuss opportunities and actions to tackle obstacles in the research and development community. Ison In addition, the WHO vaccine biomanufacturing training hub in Korea was presented to the world, which has presented positives to the changing geographical shift towards low to middle income countries in equitable quality in epidemiology in countries such as Africa and Latin America.

On 24 May 2023, it was reported that Korea invited all 18 Pacific Island Forum (PIF) nations including, but not limited to: Papua New Guinea, Fiji, Tuvalu, Palau, Australia, and New Zealand, for a summit, who are key partners for Korea's goal for foreign policy. The upcoming summit plans to hold discussions around responses to health crises.

On 26 May 2023, WHO and Korea signed a Memorandum of Understanding to create a global training hub in biomanufacturing. The global training center will produce vaccines, monoclonal antibodies, and cancer medicines to service low and middle-income countries. WHO and Korea believe this collaboration will address the gap of equitable access in healthcare and biologicals.

On 4 June 2023, Samsung Biologics, Celltrion, and other Korean biotechnology companies took part in the BIO International Convention held in Boston, to promote Korean technologies and products. The convention is one of the largest events for the global bio industry and will feature 544 Korean companies, ranking second after the U.S. in the number of participants.

On 6 June 2023, the Government announced that it plans to expand the exportation of medical services by accepting more foreign patients and applications of overseas expansion until 2027 and offering policy support to achieve this initiative. To improve accessibility for foreign patients, the government plans to focus on changing immigration procedures for them and use the rising K-culture to promote this goal.

On 7 June 2023, the Government announced that it would grow the local biotechnology industry's production capacity to KRW100 trillion by 2030, as a part of their goal to become a world-leading biotech company and economy. 1813

On 8 June 2023, Samsung Biologics signed a KRW535 billion contract manufacturing organization (CMO) deal with Pfizer, for long-term production of medicines. Pfizer Chief Global Supply Officer Mike

McDermott sees the cooperation as a sign of Pfizer's trust in the Korean pharmaceutical industry and hopes to together, provide Medicare for patients globally.

On 16 June 2023, Korea announced plans to donate KRW70 million in 2023 to Gavi, an international health organization which works as a coordinator to the development and distribution of COVID-19 vaccines. At the meeting, Korean ambassador to Spain Park Sang Hoon emphasized Gavi's prominent role in vaccine distribution and the Korean government's ongoing commitment to improving the global health system.

On 1 August 2023, it was reported that the Minister of Health and Welfare Cho Kyoo Hong of Korea recently discussed with the Australian Ambassador to Korea Catherine Raper, about cooperation in the health and welfare section. At the meeting, Minister Cho also emphasized the importance of international cooperation to achieve better health security.

On 12 August 2023, Foreign Minister Park Jin of Korea visited Kigali, Rwanda, where with Foreign Minister of Rwanda Vincent Biruta signed an agreement which one of the promises were that Korea would increase their development cooperation to health. 1817

Korea has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. It has engaged with allies by providing medical aid and personnel, and repeatedly cooperated with the WHO through sharing information and combining efforts.

Thus, Korea receives a score of +1.

Mexico: 0

Mexico has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 22 November 2022, Secretary of Tourism Miguel Torruco Marqués announced in a meeting for the Training and Development for Health Tourism Clusters Program that government regulation and private sector coordination are successfully making health tourism one of the most profitable and contributing sectors to the Mexican economy. Mexico plans to keep growing this sector by installing new health centers and 'fast line' passes for facilitated traveling.

On 16 December 2022, Mexico issued new rulings in favor of tightening tobacco control actions, adding to the previously amended General Law for Tobacco Control. Mexico's efforts toward tobacco control align with the Pan American Health Organization's (PAHO) work to support countries to adopt the WHO Framework Convention on Tobacco Control which promotes tobacco control measures. PAHO/WHO Representative Dr. Juan Manuel Sotelo congratulated the Mexican Ministry of Health for the new rulings.

Mexico has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. It has engaged with

Russia: 0

Russia has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 15 December 2022, the Ministry of Health approved the 17th version of the Interim Guidelines for the Prevention, Diagnosis and Treatment of a New Coronavirus Infection. This version included updates on the known circulating strains of Covid-19 as well as recommendations for the diagnosis and treatment of influenza during the ongoing Covid-19 pandemic. This version also updated criteria for prescribing anti-inflammatory drugs and updated the sections on the management and emergency treatment of patients with Covid-19. These guidelines are posted on the official website of the Ministry of Health of Russia and were disseminated to regions for practical work.

On 15 December 2022, the Ministry of Health held a meeting between Deputy Minister of Health of Russian Federation Tatyana Semenova and Deputy Minister of Health and Medical Industry of Turkmenistan Murat Mammedov in the establishment of healthcare ties between Russia and Turkmenistan. The meeting highlighted interests in continuing medical education, medical tourism and the digital transformation of health. Deputy Minister Semenova highlighted Turkmen medical specialists trained in Russia under additional professional education programs with an emphasis on the use of modern medical equipment. Deputy Minister Mammedov highlighted his appreciation for the cooperation of Russia throughout the pandemic, noting Turkmenistan as one of the first members to receive a Russian vaccine, Sputnik V, for the prevention of Covid-19. Both members agreed to strengthen healthcare sector contacts in 2023.

On 17 December 2022, the Ministry of Health announced the opening of a high-tech tablet shop at the Saransk Biochemist Plant, which aims to reduce the dependence of foreign supplies of pharmaceutical products. 1822

On 28 December 2022, the Ministry of Science and Higher Education supported scientific centers that carry out research and development in accordance with the priorities of scientific and technological development. These goals were set as part of the national project 'Science and Universities.' Russian researchers are working to improve the effectiveness of cancer therapy which would then avoid the cost of additional medicines and services during supportive care, rehabilitation and palliative care. Researchers are working toward the development of modern medical devices which will be convenient for patients.

On 29 December 2022, the Ministry of Health announced the launch of a pilot project to monitor the health status of patients using remote high-tech devices and services. 1824 The project is spearheaded by the First Deputy Prime Minister Andrey Belousov who states that about 200 people are participating in the project to ensure formation of a regulatory and methodological framework for doctors to work with remote monitoring data for diagnoses.

On 3 March 2023, Minister of Health Mikhail Murashko and Minister of Health of Social Protection of the Republic of Tajikistan Jamoliddin Abdullozoda, signed an intergovernmental agreement on cooperation in the field of healthcare, medical education and science. The agreement ensures the parties cooperate under areas such as the prevention, diagnosis, and the treatment of infectious and non-communication diseases, maternal and child health, promoting a healthy lifestyle, state regulation of the circulation of medicines and the training of medical specialists and their participation in conferences.

On 15 March 2023, Minister Murashko, and Sri Lankan Ambassador to Russia Janita Liyanage met to discuss the development of existing and new areas of Russian-Sri Lankan cooperation in the field of health care. 1826 Minister Murashko announced that the COVID-19 pandemic expedited the deployment of digital technologies in the healthcare system. Ambassador Liyanage announced her gratitude to Russia for its cooperation and willingness to engage in the field of healthcare. Russia and Sri Lanka agreed to hold a series of consultations with specialists in the field of pharmaceuticals, education, digitalization and noted the importance of direct contacts between the Ministry of Health of Russia and the Ministry of Health of the Republic of Sri Lanka.

On 25 March 2023, Minister Murashko and the Minister of Health of the Republic of Uzbekistan Amrillo Inoyatov reaffirmed their intentions to strengthen and expand healthcare partnerships. Mikhail Murashko noted that Russia is prepared to exchange expertise with Uzbek partners in regard to innovative pharmaceutical developments and the development of modern technologies. The meeting pointed toward actions dedicated to improving the skills of medical staff. In addition, Minister Murashko discussed one of the key vectors for the development of the national healthcare system being working remotely with patients, perhaps with a program using artificial intelligence.

On 28 March 2023, Minister Murashko, met with the Chairman of the National Council of the Republic of Namibia, Lucas Sinimbo Mucha. 1828 The conversation emphasized that the Ministry of Health of Russia is open to cooperation with the Republic of Namibia in several areas, with Minister Murashko stating that healthcare is one of the main areas of cooperation between the two nations. Chairman Mucha stated that Russia consistently supports Namibia, particularly expressed when Russian doctors came to Namibia to help their healthcare system, as well as their acceptance of students to study in medical specialties. Both

parties exchanged views and proposals in the field of medical education, the advanced training of specialists, medical tourism, drug provision of the population, and high-tech medical care. One of the main topics of the conversation was the development of medical care in rural areas, as well as the bilateral exchange of experience in the area between both parties.

On 17 April 2023, it was announced that scientists from the Institute of Cytology of the Russian Academy of Scientists, under the Russian Ministry of Education and Science, have shown that known antifungal drugs block the spread of COVID-19.1829 Specifically, it was shown that several compounds of the cyclic lipopeptide class are able to block the fusion of the SARS-CoV-2 virus in a cell. The results of this study was supported by a grant from the Russian Science Foundation, and continues the work by the staff of the Laboratory for Modeling Membrane and Ion Channels of the Institute of Scientific Centers of the Russian Academy of Sciences.

On 21 April 2023, it was announced that an electrochemical method for assessing the effect of a drug on DNA was developed by scientists from the V.N. Orekhovich Research Institute of Biomedical Chemistry, under the Russian Ministry of Education and Science. Specialists noted that in the future, the electroanalysis method can be further developed and adapted for its use in medical practices, for assessing the toxic effect of DNA of drug compounds at the developmental stage, and for studying the effect of new forms of delivery of already known drugs.

On 17 May 2023, it was announced that Russian scientists have found a promising antibacterial agent. 1831 Scientists are said to have found a more effective way to treat bacterial infections with the use of triphenylphosphonium derivatives, an organic compound used to deliver drugs into infected cells. Scientists seem to have proved that triphenylphosphonium derivatives can act as antibiotics, meaning that it is capable of killing pathogens that damage cells. Results of the study are supported by the Russian Ministry of Education and Science, the Russian Foundation, and the Russian Foundation for Basic Research. The results have also been published in an international scientific journal.

On 27 July 2023, Minister Valery Falkov and the Minister of Innovation and Technology of the Federal Democratic Republic of Ethiopia Belete Molla, signed an agreement on the establishment of the Russian-Ethiopian Center for Biological Research.¹⁸³² The primary tasks of this project include studying biodiversity, the evolution of living organisms, the biological resources of Ethiopia, and identifying promising animal species for use in the national economy and assisting in the training of national scientific personnel through the joint participation of scientists. This work is projected to have implications not only for Ethiopia, but for the entire world.

On 4 August 2023, Deputy Minister Glagolev took part in the meeting of the Ministers of Health of the BRICS countries in Durban, South Africa. During the meeting, discussions surrounded combating the spread of infectious diseases, the prevention and treatment of non-communicable diseases, and the development of pharmaceuticals. Deputy Minister Galgolev noted that Russia paid much attention to the treatment and prevention of non-communicable diseases, and the nation is willing to share the experience

with BRICS partners. It is noted that Russia became the initiator of this conversation within the discussion of the BRICS partnership, additionally offering cooperation in the field of nuclear medicine. Deputy Minister Glagolev noted that the potential of BRICS is not only within the association, but also in aiding countries in need.

Russia has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. It has cooperated with other nations to develop health care, including Tajikistan, Turkmenistan and Sri Lanka. It has also spearheaded research initiatives for the betterment of national and international health outcomes. However, Russia has made no move to interact or collaborate with WHO and international organizations.

Thus, Russia receives a score of 0.

Saudi Arabia: +1

Saudi Arabia has fully complied commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 6 February 2023, Saudi Arabia debuted new technology to be implemented within healthcare facilities throughout the country. 1834 This technology serves to improve the quality and development of health care through the use of the metaverse, artificial intelligence, virtual reality and blockchain.

On 13 April 2023, Saudi Arabia fulfilled their pledge to the Global Health Fund, resulting in a total contribution of USD30 million.¹⁸³⁵ Saudi Arabia has been a large donor to the fund, with a cumulative donation of USD123 million.

On 26 April 2023, Minister of Health Fahd bin Abdurrahman affirmed the country's continued support for WHO programs working to achieve global health. 1836 After the contributions made by Saudi Arabia during the Covid-19 pandemic, they are now committed to disease eradication.

On 19 May 2023, the Saudi Fund for Development signed a USD39 million multi-year contribution agreement aimed at fighting global pandemics and working toward a strengthened global health system. 1837

On 6 June 2023, the Ministry of Health announced their plans to host the upcoming 2023 Global health Exhibition, to be held from 2 to 4 October 2023. 1838 The exhibition will showcase new health sector technology, as well as seminars centered around teaching participants new medical discoveries and continuing medical education.

On 18 August 2023, Minister of Health of Saudi Arabia Fahad Al-Jalajel and the Director-General of the WHO Tendros Adhanom Ghebreyesus held a meeting in Gujarat, India. 1839 This meeting discussed progress made in Saudi Arabia regarding their development in digital healthcare, patient safety and emergency health responses.

Saudi Arabia has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. With regards to strengthening global health governance, Saudi Arabia has signed agreements to provide financial aid to Yemen to go toward the development of their medical infrastructure. Saudi Arabia has also begun the process of implementing new technologies within their healthcare system through their partnership with Digital Diagnostic and their implementation of AI technology, in which their success would lead to the improvement of healthcare delivery and diagnosis worldwide. However, Saudi Arabia must take stronger action towards helping strengthen global health governance in other nations.

Thus, Saudi Arabia receives a score of +1.

South Africa: 0

South Africa has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 17 November 2022, the Ministry of Health announced that it had implemented a national measles response plan with the support of WHO.¹⁸⁴⁰ The Ministry conducted a mass measles vaccination campaign in all provinces, targeting children aged 6 months to 15 years.

On 3 April 2023, during the 5th Global Forum on Human Resources for Health held at WHO Headquarters, South Africa, as part of the African Union Development Agency (AUDA), joined WHO and the International Labour Organization (ILO) in a joint effort to strengthen the capacities of African countries in dealing with occupational health and safety measures for safeguarding health workers.¹⁸⁴¹

South Africa has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. South Africa has engaged with organizations including WHO, the African Union Development Agency and the ILO in addressing global health concerns, but has not taken sufficient action to emphasize their leading role in health governance.

Thus, South Africa receives a score of 0.

Türkiye has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 3 February 2023, Türkiye announced its partnership with Supply Vaccines to Eliminate SINOVAC, a leading provider of biopharmaceutical products in China. This will allow for enhanced pediatric healthcare and an improvement in the distribution of vaccines to the Turkish population.

On 11 April 2023, President Recep Tayyip Erdogan made a public address vowing to turn Türkiye into a "global center of attraction" in the field of healthcare. President Erdogan wants to expand healthcare services to interested foreign citizens as their established infrastructure would be a valuable contribution to global health services.

Türkiye has partially complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. Türkiye has partnered with SINOVAC to improve pediatric and overall healthcare in Türkiye and has also indicated an interest in expanding its role in the international health system. However, Türkiye has yet to take strong action in global health governance, either in conjunction with WHO or other international organizations.

Thus, Türkiye receives a score of 0.

United Kingdom: +1

The United Kingdom has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 8 December 2022, the UK Health Security Agency (UKHSA) published the UK's plan to reduce and eventually eliminate monkeypox (mpox) transmission in the UK. 1844 The strategy builds on the effort from earlier in 2022 to reduce cases. The UKHSA's efforts are in accordance with WHO's recommendations for controlling and ultimately eliminating mpox in the WHO European Region.

On 10 January 2023, the Department of Health and Social Care announced the extension of its free personal protective equipment (PPE) scheme until 31 March 2024 or until the department's supply of Covid-19 stocks are depleted, depending on whichever is sooner. The scheme ensures the free provision of clinical or medical-grade PPE to eligible beneficiaries. The scheme supports the UK's Covid-19 response during global inflation and cost of living pressures. The extension of the scheme aligns with WHO's guidance and other bodies and expert agencies to increase PPE usage for Covid-19 infection control.

On 13 March 2023, the WHO Health Workforce and Health Education England (HEE), the strategic workforce body for England's National Health Service, began their joint planning and leadership program, "Working for Health 2030: Building Health Force Leadership." The program hosted leaders in the field of workforce planning to deliver the first of four seminars which aimed to discuss priorities for health systems delivering primary care in the context of Covid-19. The WHO and HEE intend to strengthen health workforce leadership and capability and capacity to improve health outcomes for populations.

The United Kingdom has fully with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. It has followed WHO's guidance in controlling both mpox and Covid-19, while also cooperating with international organizations such as the Global Fund to support the global health system.

United States: +1

The United States has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 28 November 2022, the US announced support for the WHO renaming of the monkeypox disease to mpox.¹⁸⁴⁷ Following WHO guidance, US federal departments committed to the change and adopted the term in future public health correspondences.

On 29 November 2022, the US announced a new strategy for expanding global health security partnerships. 1848 This strategy forms new partnerships with Ghana, Guatemala, Mozambique, The Philippines, Zambia and Ukraine, expanding current partnerships with 25 countries, spurring new mobilizations in existing US global health security programs and investments from the recently established World Bank Pandemic Fund and supporting implementation of assessments from the third WHO Joint External Evaluation. By helping build the capacities of more countries, the US supports compliance with the International Health Regulations and works toward reaching the 2024 Global Health Security Agenda target.

On 1 December 2022, the Department of State announced the latest update to the President's Emergency Plan for AIDS Relief (PEPFAR).¹⁸⁴⁹ This global health program is part of the international effort to fulfil the United Nations Sustainable Development Goal of ending the global AIDS emergency by 2030.

On 13 December 2022, the US Agency for International Development (USAID) announced partnerships with the governments of Côte d'Ivoire, Ghana, Kenya, Malawi and Nigeria for the Primary Health Care Collaborative program during the US-Africa leaders' summit. This program will be supported by USD415 million annually and aims to boost primary healthcare outcomes in the above countries in accordance with the US President's Malaria Initiative and PEPFAR.

On 13 December 2022, the Government announced the future procurement of 15 million locally African produced AIDs tests by 2025 at a cost of USD20 million as part of PEPFAR during the US-Africa leaders' summit. This action is meant to support the global campaign to eliminate aids while fostering development of local African drug manufacturing capabilities.

On 13 December 2022, Under Secretary of State of Economic Growth, Energy, and the Environment Jose W. Fernandez met with Korea's Second Vice Minister of Foreign Affairs Lee Do Hoon. They committed to continue supporting the Global Health Security Agenda, and signed the amended memorandum of

understanding between the Department of Health and Human Services, built on the United States-Korea Global Vaccine Partnership and to explore opportunities for further collaboration to enhance production and access to vaccines and medical supplies on a global scale.

On 14 December 2022, the USAID, in collaboration with the US International Development Finance Corporation (DFC), jointly announced the creation of the USD50 million Transform Health Fund during the US-Africa business forum. This fund is meant to work with the local private sector to support supply chain development, digitization and care delivery, particularly through woman led collaboration. The USAID and DFC pledged USD1 million in grants and USD10 million in equity funding to this initiative.

On 23 February 2023, the Centre for Disease Control and Prevention, along with the Government of India and WHO, organized a three-day southeast Asia regional epidemiology training program. This program is meant to share public health experience in the field of epidemiology and build skill among medical professionals from countries in the region.

On 6 March 2023, the HHS awarded USD250,000 in emergency funding to the Columbiana County Community Action Agency to help support people affected by the train derailment in East Palestine, Ohio. 1855 This funding is meant to enable further response and quality care for the victims affected by the crisis.

On 8 March 2023, a US delegation attended a WHO Intergovernmental Negotiating Body meeting on creating a pandemic accord. 1856 While the US underscored the need for global health governance and international cooperation to build capacity, respond in a timely fashion and break the cycle of pandemic neglect, they also declared that the US would not support any WHO measure or negotiation that undermines its sovereignty or security.

On 30 March 2023, the USAID Administrator Samantha Powers met with Bill Gates of the Gates Foundation in continuation of the partnership with the non-profit organization to achieve global health objectives. During the meeting, the two discussed the importance of encouraging advancements in key development priorities as well as the need for innovative solutions and continued partnership.

On 10 April 2023, the Biden-Harris Administration announced the USD5 billion "Project NextGen" COVID-19 response initiative. 1858 This project will help invest in and accelerate the development of new vaccines and treatments as part of ongoing efforts to mitigate and manage COVID-19.

On 13 April 2023, the United States and Australia provided Indonesia with a shipment of new oral antiviral medicine (Paxlovid) to treat COVID-19 patients through WHO.¹⁸⁵⁹ The sharing of medicine demonstrates the partnership and value of collaboration between the three countries.

On 20 April 2023, the USAID Administrator Samantha Power met with United Nations Children's Fund (UNICEF) Executive Director Catherine Russell. The two discussed cooperation on ongoing efforts to improve maternal and child survival across the globe through means such as strengthening primary health care, as well as the further inclusion of local organizations and actors in projects.

On 25 April 2023, the Biden-Harris administration announced the partnership of the US President's Malaria Initiative (PMI) with three new countries, Burundi, Togo and the Gambia. As part of this partnership, the PMI will work with and support these local countries' governments and healthcare systems' efforts in enacting malaria control measures.

On 27 April 2023, the HHS announced the awarding of nearly USD149 million to 49 recipients as part of the initiative to end HIV in the US. 1862 USD139.1 million dollars of this funding will go towards improving the capability of local healthcare systems in areas with high levels of HIV transmission to support patients with treatment. Meanwhile, a remaining USD8 million will be provided to non-profit organizations for the provision of additional training and resources to those recipient local healthcare systems.

On 16 May 2023, the HHS Secretary Xavier Becerra participated in the G7 Health Ministerial Meeting in Nagasaki, Japan. 1863 During the meeting, delegates discussed pandemic preparedness within the global health architecture and methods for improvement and greater collaboration.

On 17 May 2023, the HHS Secretary Becerra met in Brussels with the Commissioner for Health and Food Safety of the European Union and other representatives to launch a joint EU-US Health Taskforce. The taskforce will expand bilateral cooperation on important issues such as strengthening the global health architecture, mitigating global health threats, and combating cancer. 1865

On 21 May 2023, the HHS Secretary Becerra attended the WHO's 3-day 76th World Health Assembly. 1866 During this conference, leaders discussed the importance of collaboration and coordination in the global health system and ways to strengthen global health architecture.

On 23 May 2023, the USAID signed a USD31 million partnership with the government of Senegal. 1867 The funds from this agreement will be used over 4 years to improve maternal, child, and adolescent health services in the country, as well as combat malaria.

The United States has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of WHO and support from other international organizations. The US has provided funding to international health programs, supported WHO initiatives and collaborated with various non-governmental organizations to achieve global health outcomes. Moreover, it has launched numerous bilateral initiatives to increase public health accessibility and equity.

Thus, the United States receives a score of +1.

European Union: +1

The European Union has fully complied with its commitment to strengthen global health governance, with the leading and coordination role of the World Health Organization (WHO) and support from other international organizations.

On 6 December 2022, the European Commission's Health Emergency Preparedness and Response Authority (HERA) and the WHO Hub for Pandemic and Epidemic Intelligence agreed to strengthen cooperation in regard to countermeasures to "prevent, prepare, detect, and rapidly respond to serious crossborder threats to health."1868 This agreement is in line with the EU's Global Health Strategy and the agreement between the Commission and the WHO to increase collaboration against global health threats. HERA and the WHO Hub plan to work together under the European Health Union to cooperate when developing work plans and research maps to consider agendas and the overall advancements of medical countermeasures and related technologies.

On 27 December 2022, WHO published a technical document announcing a three-year EUR40 million project of the European Union and the WHO Regional Office for Europe in six countries of the Eastern Partnership: Armenia, Azerbaijan, Belarus, Georgia, the Republic of Moldova, and Ukraine. 1869 The project emphasizes supporting national vaccination systems and data management, providing health professionals with capacity-building opportunities, the delivery of immunization services and risk communication and community engagement.

On 26 January 2023, the European Commission adopted a decision to improve the quality of medicines in the EU. 1870 This decision creates more trust in the quality of active substances produced in Canada. Active substances manufactured in Canada, for example, with the intent of being placed on the EU market, must be manufactured in a EU equivalent regulatory system including rules for good manufacturing practices to guarantee quality.

On 8 February 2023, the European Commission hosted a Supporting Knowledge and Capacity Building Workshop with the National Contact Points (NCPs) to Improve Information to Patients on their rights on

cross-border healthcare. 1871 The workshop aimed to address several recommendations following the evaluation of cross-border health care. The workshop concluded with a discussion regarding NCPs' needs and how the funds from the EU4Health programme can be used to strengthen the implementation of the Cross Border Healthcare Directive 2011/24/EU.

On 7 February 2023, the EU and Moldova strengthened engagement and cooperation in several areas, in line with Moldova's commitments under the EU-Moldova Association Agreement. The European Commission and the Government of the Republic of Moldova have come to an agreement to associate Moldova to the EU4Health programme, granting Moldova access to EU funding in health areas. Moldovan health authorities will be able to engage in areas dedicated to health such as mental health, the European Health Data Space, global health, non-communicable diseases and the EU network of Comprehensive Cancer Centres. Private and public sectors will also be allowed to apply for funding to support actions including that of cross-border health threats, the prevention of chronic respiratory diseases, improving mental health for vulnerable groups as well as improving health systems and healthcare services.

On 14 March 2023, HERA and the European Centre for Disease Prevention and Control (ECDC), and HERA and the European Medicines Agency agreed to increase cooperation and coordination to better support health emergency preparedness and response. HERA and ECDC have identified several areas of collaboration, including that of intelligence gathering and assessment of health threats, modeling activities relevant to medical countermeasures, promoting advanced research and development in medical countermeasures, strengthening knowledge in preparedness and response related to medical countermeasures and contributing to reinforcing the global health emergency preparedness and response architecture.

On 28 March 2023, the WHO released an article announcing that the WHO Country Office in Ukraine, with support from the EU and the United States Agency for International Development (USAID), has donated 33 ambulances to the Ministry of Health of Ukraine to allow for continued emergency medical care to patients during the war. ¹⁸⁷⁴ The ambulances were given on 27 March 2023 in Lviv at a ceremony held with the Ministry of Health of Ukraine, EU Humanitarian Aid, and USAID. The ambulances will be distributed across hospitals and emergency medical centres in the country, with a focus on the eastern part of Ukraine. ¹⁸⁷⁵ This donation hopes to increase the timeliness and quality of health services provided in Ukraine, as well as reduce mortality rates from emergency situations and mass casualty events.

On 24 April 2023, the European Commission announced that it will allocate EUR106.2 million to Belgium, France, Germany, Italy, Luxembourg, Portugal, Romania and Türkiye to develop the new rescEU EMT (Emergency Medical Team) capability. The objective of this team is to increase emergency medical

support to populations affected by large natural or man-made disasters. The capability of the rescEU EMT will become operational as of 2023 and will allow a response to a great range of disaster scenarios.

On 26 April 2023, the European Commission proposed to revise the European Union's pharmaceutical legislation to make it more agile, flexible, and adaptable to the needs of citizens and businesses across the EU.¹⁸⁷⁸ The revision will make medicine more available, accessible, and affordable. In addition, it will support innovation and increase the competitiveness, while promoting higher environmental standards, of the EU pharmaceutical industry. In addition to this reform, the European Commission has promised a Council Recommendation to increase the fight against antimicrobial resistance. The next steps include submitting the legislative proposals to the European Parliament and the Council.

On 27 April 2023, State Secretary for Health Dr. Péter Takács had his first official visit to the WHO Regional Office for Europe. Some key points of the agenda of the dialogue included operationalizing the One Health approach and expanding digital health and artificial intelligence health initiatives in Hungary to generate stronger health data. In addition, investing in the health and care workforce to address long-term challenges that came to the surface throughout the pandemic was discussed.

On 17 May 2023, Commissioner for Health and Food Safety Stella Kyriakides and other representatives met with the United States Health Secretary Xavier Becerra to launch a joint EU-US Health Taskforce. The taskforce will expand bilateral cooperation on important issues such as strengthening the global health architecture, mitigating global health threats, and combating cancer. 1881

On 9 June 2023, the WHO released an article reporting on the thirty medical teams that visited communities in North Macedonia as a part of a door-to-door campaign funded by the European Union. This campaign aimed to address and reduce vaccination inequities. This five-week initiative was launched in April 2023, and was to help overcome the social, economic, physical or individual obstacles that impede on people's access to COVID-19 vaccines, among several others. The campaign serves as an example of service delivery to communities through data-informed decisions, as described by the European Immunization Agenda 20230 adopted by all Member States of the European Region. The door-to-door campaign was a section of a EU-funded project which aims at strengthening health systems in the Western Balkans. The project is being implemented in Albania, Bosnia and Herzegovina, Montenegro, North Macedonia, Serbia and Kosovo.

On 13 July 2023, Japan and the European Union held their 29th summit in Brussels in which they committed to enhancing health security. This commitment included the strengthening of health security through plans to improve global health architecture, work toward universal healthcare coverage, and strengthening pandemic prevention and response.

It is through strengthening relationships inside the Union, as well as outside the Union, that the EU has successfully committed to advancing global health outcomes and measures.

Thus, the European Union receives a score of +1.
